# THE PRESIDENT SPEAKS

### **Mixed Blessings and Rays of Hope!**

"My 'Swaraj' is to keep intact the genius of our civilisation. I want to write many new things but they must all be written on the Indian Slate. I would gladly borrow from the West when I can return the amount with decent interest". - Mahatma Gandhi.

Happy Independence Day on the 15<sup>th</sup> of August. We can proudly state that Swaraj (self rule or independence) has been our birth-right for the last sixty-eight years. We have our own civilisation to be proud of, besides our heritage. The new things that have been written on the Indian Slate, which has weathered wars, the Emergency era and the progressive economic development of India's awakening to make her tryst with destiny on its unending journey, to become one of the world's most influential nations, helps us to keep us going. It was a one to one session with just two of us in the VIP lounge exchanging notes on various subjects. The rapport Dr Kalam enjoyed with his personal staff and his concern in taking care of their wellbeing was touching. Dr Kalam had a very good knowledge of Mangalore, its history, people and its industrial potential. I had to answer personal questions, professional matters followed next and my opinion on how Indian shipping fared at the international level was well taken. The diplomacy par excellence was personified, when I asked him boldly on the silence that he was maintaining on the Nuclear Pressler Amendment 123 when the issue was rocking the nation then. The answer was short and sweet, 'I will, when it is needed', with that famous smile.

Dr Kalam never spoke on the evils of corruption but fought corruption by walking the talk igniting and awakening the youth, inculcating dreams and visions. Finally, let me add that Dr Kalam wrote many new things on the Modern Indian Slate in every public office that he held, to make all Indians proud. May Dr Kalam's soul rest in peace.

I am happy to inform that Fr Muller Charitable Foundation (FMCF) in the US has informed CASK that they will continue to support the Eye Care Project for the following year too. CASK is grateful to Drs Vinaya and Sameer Kapoor for their generous contribution of USD 10,000 for the third successive year and M/s Atlantic Sub Sea Inc, New Jersey, for matching an equal amount of USD 10,000. CASK is working with Fr Muller Medical College Hospital Management on how to reach out the eye harvesting and transplant action scheme in and around Mangalore region.

# ANNUAL REPORT: 2014-2015

The Annual Report of the Association for the year 2014-2015 is presented below:

# 1. Governing Council Meetings & AGM:

During the year, the Governing Council met eight(8) times and took important decisions with regard to the affairs of the Association and organized various activities/programmes.

The General Body meeting of the Association was held at St Aloysius College Auditorium on Sunday, 28th September 2014 - 56 members attended. At this meeting, the Annual Report and the Audited Statement of Accounts for the year 2013-2014 were duly approved/ adopted.

Since the current office-bearers and Governing Council members completed their 2-year term : 2012-2014, elections were held for the posts of 6 Office-bearers and 10 Governing Council members. Past President – Ms Lily Pereira functioned as the Election Officer. The following members were unanimously elected as **Office-bearers and GC members for the term : 2014-2016** :

During the year under review, the Valedictory function of the CASK Centenary celebrations was organized in a grand scale. The projects in honor of the CASK Centenary, aimed at benefitting the marginalized groups were launched and many activities/programmes were organized in line with the aims and objectives of CASK.

## 2. SUB-COMMITTEES

The following Sub-Committees were formed for the term 2014-16. The conveners of the sub-committees for the year 2014-2016 are :

Mr Walter D'Sa - Administration and Finance; Dr Derek Lobo – Centenary Projects and Centenary Trust; Mr Winston D'Souza – Medical Aid & Organ Donations; Ms Terry Pais – Social Issues; Ms Nayana Fernandes – Scholarships & Cultural Issues; Ms Patsy Lobo – Personality Development Programme; Editorial Team – Patsy Lobo(Editor), Mr Zozimus Pais, Dr Anand Pereira, Joan Lobo

**CASK Centenary Celebration Committee** with Capt J.P.Mernezes as Convener and **CASK Centenary National Steering Committee** with Mr Vivek Aranha of Pune as Chairman, functioned effectively until the Valedictory function of the Centenary Celebrations on 21<sup>st</sup> September 2014 and were then disbanded.

**PATRON OF CASK** - The President and office bearers of the Association periodically met the Patron of CASK-Most Rev.Dr. Aloysius Paul D'Souza, Bishop of Mangalore and briefed him about the activities of CASK and sought his guidance.

# 3. ADMINISTRATION and FINANCE

Since 2010-2011, the Administration and Finance Management of the Association has been streamlined. The membership records, accounts and the subscriber list of "Mangalore" were computerized and constantly updated.

In pursuance of the decision of the General Body, the **CASK Centenary Trust** was formed and duly registered in July 2014. We have now obtained a PAN CARD in the name of the Trust and opened a Current Account at The South Indian Bank-Mangalore.

**Capital Fund** – The Life Membership fees collected during the year amounted to Rs.50,000 which has been taken to the capital fund. As in the previous year, the same will be invested in fixed deposit.

**Franklin Mathias Education Fund** – The core amount of this Fund is Rs.6,00,000. Interest accrued on investments during the year was

Rs.54,000 which along with the balance carried forward from the previous year viz.Rs.6,25,182 amounted to Rs.6,79,182. This year, CASK granted scholarships worth Rs.25,000 to 4 students and one handicapped(wheel-chair bound). An amount of Rs.54,182/- is available for scholarships during 2014-15.

**Building Fund** – The Building Fund amounting to Rs.65,625 as on 31March 2014 was merged with the CASK Centenary Celebration Fund since CASK purchased a 550 sq. feet Office premises at Pio Mall, Bejai, Mangalore, from the Capuchin Fathers. The cost of the Pio Mall Office premises including Registration and Office furniture/equipment etc. came to **Rs.24,30,037**. The longstanding dream of CASK to own its own office premises was fulfilled during the Centenary year

**CASK Centenary Celebration Fund** - As the CASK Centenary Year came to a close with the valedictory function held on 21 September 2014, an account of the entire donations/interest on investments received and the amount spent/disbursed of the CASK Centenary Fund from inception upto 31 March 2015 is summarised below:

The surplus of **Rs.24,04,186.90** has been invested in fixed deposits(FDs) and used for other CASK Projects. The FDs with banks

stands at Rs.30,88,979.00 as on 31 March 2015.

**"Mangalore" Magazine** : The expenditure in publishing 'Mangalore' magazine during the year amounted to Rs3,36,554.75 and the receipts by way of subscriptions, advertisements, sponsorship, etc amounted to Rs.3,20,437.98 resulting in a **deficit** of Rs.16,116.77. This is mainly due to the pending payment of an Advertisement bill. If arrears in subscriptions/advertisements come in time and sufficient advertisements/ sponsorships secured, 'Mangalore' should be providing some surplus funds to the Association. Efforts are in this direction.

**Income Tax Assessment** : The income tax assessment of the Association for the year 2013-2014 has been completed.

## 4. MEMBERSHIP

- **4.1. Life Members** During the year 2014-2015, 50 new life members were enrolled, bringing the new members enrolled since October 2010 to 237. The life membership fees collected i.e. Rs50,000 has been taken to the Capital Fund.
- **4.2.** Subscribers to Mangalore Magazine During the year 2014-15, 11 Founders, 7 Benefactors, 105 Life Members, 71 new Life Members and 43 Annual Members subscribed or renewed their subscriptions. The total amount of subscription fees collected was Rs2,15,312.92. The subscribers for the 'Mangalore' magazine including those on the free mailing list comes to **1,264** (Founders-48, Benefactors-39, Life Members-698, members residing abroad-75, Annual subscribers-149, members on Free Mailing List-138 and members whose subscription has lapsed-117.

# 5. PROGRAMMES & ACTIVITIES

**5.1. Personality Development Programme -** This is an ongoing programme since 2011-12 - CASK started the programme in two Parish Schools-St Aloysius High School, Urwa and Rozario High School, Bolar. A total of **249** students from the 2 schools benefited from the programme.

During 2012-2013, the programme was included as a CASK Centenary project and received a boost with a donation of Rs.2 lakhs by Mr Anthony D'Silva Prabhu of USA. The programme was organized in 5 schools during 2012-2013 and during 2013–2014, with a total of **786 students** from the 5 schools

benefitting.

During the year under report(2014-15) the programme was conducted in 5 schools and 2 colleges as follows : St Aloysius Gonzaga School-Kodialbail; Mount Carmel Central School-Mary Hill; Lourdes Central School-Bejai; Carmel School-Bolar; St Theresa's School-Bendur; St Aloysius Institute of Education; St Agnes College. A total of **366 students** from the 7 institutions benefitted. The total number students that participated and benefitted from the start of the programme in 2011-12 to date is **1,158**.

5.2. Promotion of Blood, Blood Products, Organ and Whole Body Donations - This is a CASK Centenary project. CASK donated a deep freezer to the Blood Bank of Fr Muller Hospital(cost of Rs.6.25 lakhs defrayed by Mr Vivek Aranha & Family, Pune) and has collaborated with the Fr Muller Instututions in three areas (a) Supporting Eye Care Services (b) Increasing the mortuary capacity from 8 to 14 and (c) Promoting the concept of corneal and whole body donations. The Freezer enables 'plasma' an important blood product to be stored for a longer period of 3-5 years.

Through effective lobbying by CASK, the Fr Muller Charitable Trust of USA(FMCTU) donated a sum of USD-27,500/-(approx.Rs.12,50,000/-) towards enhancing the Corneal transplants and Eye Care at Fr Muller Institutions. **The contribution came from Drs Vinaya and Sameer Kapoor and was transferred from FMCTU to Fr Muller Charitable Institutions(FMCI).** We are deeply grateful to them. Under this project, CASK in collaboration with FMCI organized 4 Eye Camps and one Paediatric Camp as follows : Holy Cross Hospital, Chikmagalur – 24 August 2014 – 256 persons examined, 108 free spectacles given and 30 referred for free surgery.

Fr L.M.Pinto Health Centre, Badyar – Eye Camp on  $16^{th}$  November 2014 - 231 persons examined, 130 free spectacles given and 26 referred for free surgery.

Fr L.M.Pinto Health Centre, Badyar - Paediatric Camp on 18<sup>th</sup> January 2015. 134 children examined, 10 referred for free investigations/ surgery at Fr Mullers.

Concetta Hospital, Kinnigoly – Eye Camp on 19<sup>th</sup> April 2015 – 133 persons examined, 68 given free spectacles and 24 refered for surgery.

Holy Cross Hospital, Chikmagalur – Eye Camp on 12<sup>th</sup> July 2015 – 249 people examined, 138 given free spectacles and 26 referred for surgery.

CASK is actively promoting Whole Body Cadaver donations to FMCI for teaching and research purposes. Through the Fr Muller Charitable Trust-USA, funds were provided to increase the mortuary capacity of Fr Muller Hospital from the present 8 to 14, in order to promote cadaver organ transplants.

# **5.3.** Valedictory Function of the CASK Centenary Celebrations and Implementation of Centenary Projects

The Valedictory Function of the CASK Centenary Celebrations was held on a grand scale befitting the centenary milestone, on Sunday, September 21, 2014.

It started with a Thanksgiving Mass at the Milagres Church in the morning led by the Patron of CASK – Most Rev Aloysius Paul D'Souza. Fr Denzil Lobo, Rector-St Aloysius College preached an apt Homily. This was followed by lunch for the inmates of 7 charitable institutions of Mangalore. The lunch at Prashanth Nivas was sponsored on behalf of CASK by Mrs & Mr Christo Noronha in honor of the 80<sup>th</sup> birthday of his mother – Mrs Rene Noronha and the lunch at other 6 institutions was sponsored by Victor & Alina Pais of New Jersey-USA.

The formal Valedictory function was held in the evening at the Milagres Hall. The Hon'ble Vice-President of India – Sri Hamid Ansari was the Chief Guest and The Hon'ble Governor of Karnataka – Sri Vajubhai Vala was the Special Guest of Honor. Sri Ramnath Rai, District-In-Charge Minister represented the Chief Minister of Karnataka-Sri Siddaramaiah. Sri M.S.Ramanujam, Chief Postmaster General-Karnataka and Sri Eric Gonsalves, IFS(Retd), Former Ambassador were also present. His Lordship Aloysius Paul D'Souza, the Bishop of Mangalore and the Patron of CASK presided. At this function, the following special events related to the CASK Centenary took place :

**5.3.1.** Release of the CASK Centenary Souvenir – The Centenary Souvenir was formally released by the Hon'ble Vice-President of India.

- 5.3.2. Release of the Special Postal Cover and 'My Stamp' with the CASK Logo was brought out in honor of the Centenary. The album containing the Special Postal Cover and 'My Stamp' was handed over by Sri M.S.Ramanujam, Chief Post Master General, Karnataka Circle to the Hon'ble Vice-President, who formally opened and released them.
- **5.3.3.** The CASK Anthem composed and Music written by Ms Giselle Mehta.
- **5.3.4.** The CASK Centenary Poem titled 'The Heritage Building' was composed by Professor Geralyn Pinto.
- **5.3.5.** Handing Over of Scholarship Cheques A total of 110 Scholarship cheques of Rs.5,000/- each, totalling Rs.5.5 lakhs were handed-over to 110 students from 24 P.U.Colleges from DK and Udupi districts.
- 5.3.6. Release of the Konkani Version of the Book 'Gandhi's Outstanding Leadership' authored by Pascal Alan Nazareth IFS(Former Ambassador) was done by the Bishop of Mangalore Most Rev Dr Aloysius Paul D'Souza.
- **5.3.7.** Handing Over of a Cheque of Rs.3.5 lakhs to the Bishop of Mangalore for the Diocesan 'Home for the Homeless' Project.
- 5.3.8. Handing Over of a Cheque of Rs.25,000/- to the 'Poor Patient Fund' of Holy Cross Hospital-Chikmagalur
- 5.3.9. Recognition of Centenary Star Donors The 5 Centenary Star Donors who had contributed or pledged >Rs.10 lakhs were duly recognized and thanked during the Welcome Address by the President of CASK The Pinto Family of 'Rosedale' Mangalore, Mr & Mrs Michael D'Souza of Dubai, Drs Vinaya and Sameer Kapoor of USA, Mr & Mrs Vivek Aranha & Family-Pune and Mr & Mrs Ronald Colaco & Family-Bangalore. The names of all other donors were prominently displayed in the hall.
- **5.3.10.** Cultural programme The formal events were followed by enacting of a humurous play 'Around the World in Sixty Minutes' written and directed by Patsy Lobo with the cast consisting of CASK members. This was a befitting climax to the conclusion of the CASK Centenary.

## 6. Other Programmes Organised

- 6.1. Talk by Mr Richard Saldanha, former Chairman & CEO, Unilever, Peru-South America – CASK organized a talk by Mr Richard Saldanha to the students of Aloysian Institute of Management & Information Technology(AIMIT) on 4<sup>th</sup> April 2014. Mr Saldanha captivated the 150 students through his talk titled "Thirteen Keys to Success"
- 6.2. Felicitation to Bishop Francis Serrao SJ Bishop of Shimoga – CASK was a co-sponsor along with Sylvester Frank Foundation and the St Aloysius College Alumni Association(SACAA) of the Felicitation to the newly appointed Bishop of Shimoga – Most Rev Francis Serrao SJ held at St Aloysius High School Hall on 30<sup>th</sup> May 2015.
- 6.3. CASK Essay Writing Competition on the subject "How have things changed for the Indian Women after Independence?" The Essay Competetion was thrown open for Class-10 students of Lourdes Central School-Bejai and students of St Agnes College. 107 students from Lourdes School and 80 students from St Agnes participated.
- 6.4. Leadership Development Workshop organized by Diocesan Council of Catholic Women(DCCW), Co-Sponsored by CASK – This was a collaborative programme organized by DCCW and Co-sponsored by CASK, held on 22<sup>nd</sup> October 2014 at the Bishop's House. Mr Winston D'Souza, Governing Council Member of CASK introduced the CASK Centenary projects and explained about the eye and whole body donations. Some of the participants pledged their eyes.
- **6.5. CASK Reunion 2015** The CASK Reunion 2015 was held on 15<sup>th</sup> February 2015 at the Boat Club-Mangalore. Nearly 400 members/guests were present. The highlights of the evening:
  - Band Ecstacy a group of young college students
  - Band-Hotel Palindrone, the visiting band from Austria with Mangalore origin-Marialena Fernandes on the key-board.
  - A hilarious konkani play enacted by Mandd Sobhann
  - A carnival troupe consisting of King Momo and his queen, accompanied by lively dancing entourage in colorful costumes, fancy hats and curious masks

- Dance performance by the 'Fullabais' of Mangalore
- Enactment of "Bollywood through the Ages"
- Mock Fashion Show

The President of CASK recognized and thanked the thirteen sponsors of the Reunion function, the MC-Audrey Pinto and all the members who helped in various ways. It was certainly an event to remember!

**6.6. International Women's Day Celebration** – A Workshop on "**Changing Faces of Women in India**" was organized at Roshni Nilaya on 9<sup>th</sup> March 2015, in collaboration with the Women's Cell-Roshni Nilaya and Innerwheel Club of Mangalore North. Prof Malini Hebbar of St Agnes College was the keynote speaker. 96 students participated.

**7.PROGRAMMES DURING APRIL** – AUGUST 2015 – The following programmes and activities conducted from 1<sup>st</sup> April to August 2015 are outside the purview of the Annual Report 2014-15(1<sup>st</sup> April 2014 to 31<sup>st</sup> March 2015). However, the Governing Council of CASK wishes to inform the General Body of these activities :

**7.1.Eye Camp at Concetta Hospital-Kinnigoly on 19<sup>th</sup> April 2015** - organised by CASK in collaboration with Fr Muller Medical College. A 8-member team of doctors/Optometrists examined 133 persons of whom 68 were prescribed free spectacles and 24 were referred for free surgery or further investigations to Fr Muller Hospital.

7.2.Seminar on Issues & Concerns of the Christian Community in collaboration with Sylvester Frank Foundation - on 1<sup>st</sup> May 2015 at the St Aloysius College Auditorium. Over 200 guests participated. 6 eminent members of the community addressed the gathering : Mr F.T.R.Colaco, IPS(Retd) on "Issues & Concerns – The Way Ahead"; Mr P.D.Sebastian, Principal, SDM Law College-Mangalore on "Constitution & Minorities"; Ms Flavia Agnes, Director, Majlis-Mumbai on "Crimes against Women"; Mr Ronald Fernandes, Chief of Bureau, Deccan Herald on "Role of Media"; Fr Vinod Mascarenhas, Director, Vimukti-Ujire on "Ghar Wapsi-The Reality" and Prof Elsie Tharien – St Agnes College on "Effective Parenting in the Present Scenario"

**7.3.Distribution of Footwear for Barefoot School Students** – This is a new programme, stimulated by the fact that 20-25% of school children in rural areas come to school barefoot. This was the origin of the CASK Footwear for Barefoot School Children project. As advised by the school Headmistress, it was decided to provide footwear to all the children of two schools – St Raphael's School in Badyar (214 students) and at Anthony's Higher Primary School(206) in neighboring Gardady parish. Shoes will also be provided to those coming barefoot to 2 schools in Mangalore.

**7.4.Installation of Purified Drinking Water Facility** – We were also shocked to see that many rural schools do not have purified drinking water facility. CASK decided to give Purified Drinking Water facility to 5 schools during this academic year. 3 Purifiers are already installed to the 2 schools in Badyar and one school in Kinnigoly.

**7.5. Personality Development Programme in Kannada Medium School**. On 17<sup>th</sup> July 2015, the Personality Development Programme was inaugurated in the Kannada Medium Pompei Higher Primary School run by Urwa Parish. Sri Pithamber - Co-ordinator of the Block Resource Centre - District Education Dept was the Chief Guest. A 10-session schedule has been prepared by CASK Past President Lena Fernandes and GC member Lydia D'Cunha, who will coordinate the programme.

7.6.Distribution of Scholarships for the Academic Year : 2015-16
– It is proposed to give a total of 111 Scholarships, each of value Rs.4,000/
to 111 students from 24 P.U.Colleges at a CASK function on 14<sup>th</sup> August 2015 at St Agnes College.

**7.7.Seminar on HumanRights and Release of the Book 'Slaves of Sultans'** authored by Alan Machado Prabhu – A Seminar on 'Human Rights' will be held at St Agnes College on 14<sup>th</sup> August 2015. Renowned Human rights Activist-Fr Cedric Prakash SJ from Ahmedabad will deliver the Key-note address. At the same function, it is planned to Release the Book "Slaves of Sultans' authored by Alan Machado Prabhu of Bangalore and feliciate Dr Olinda Pereira on her 90<sup>th</sup> birthday and recognize her enormous contributions in the Education and Social fields.

## 8. COLLABORATION WITH OTHER ORGANISATIONS/ ASSOCIATIONS

CASK continued its policy of collaboration with other organizations and associations based in Mangalore in organizing various activities/ programmes during the year. The organizations/institutions collaborated include the RACHANA, Catholic Sabha, Diocesan Council of Catholic Women, Ladies Social Service League, St Vincent de Paul Society, St Aloysius College, St Agnes College, Sylvester Frank Foundation, St Aloysius College Alumni Association, Ladies Club and Fr Muller Institutions. CASK continued to be in contact with Kanara/Mangalorean Catholic Associations in Bangalore, Chennai, Mumbai, New Delhi, Kolkata and Pune and the 'Dimensions' - the Association of Catholic Entrepreneurs in Mumbai.

## 9. "MANGALORE" the Monthly Magazine

*"Mangalore"* with Mr Zozimus Pais as Editor from April-September 2014 and Mrs Patsy Lobo as Editor from October 2014 onwards supported by an Editorial team, has continued to do a commendable job in bringing out the magazine on time each month and adhered to the limit of 40-52 pages. With varied articles and News/Notes of interest, the magazine has continued to receive much appreciation from the readers.

During the year(April 2014 to March 2015), >80 persons contributed articles/views/tributes/eulogies in "*Mangalore*". Special thanks to our regular contributors – Veronica Shearer, Patsy Lobo, Joan Lobo, Flavia Agnes, John Monteiro, Drs Anand & Geeta Pereira and the 'Dreamcatcher'. Thanks are also due to the various Sponsors and Advertisers specially the Rosary Education Group-Pune and Rosedale Associates-Mangalore.

### **10. CONCLUSION**

# WHAT PRICE FREEDOM?

At the stroke of midnight on the 14<sup>TH</sup> August 1947, Pandit Jawaharlal Nehru made that soul-stirring speech which is etched in our memory. In the past 68 years India has achieved much. She is no longer thought of as a third world nation. Indian doctors, engineers and scientists, lawyers, writers and politicians have made their mark in the western world. I am proud to be Indian. Freedom has its price and we pay heavily for it. Franklin D Roosevelt said, "True individual freedom cannot exist without economic security and independence. People who are hungry and out of a job are the stuff of which dictatorships are made." This is why Pope Francis said in his first encyclical 'The Joy of The Gospel'that he wants a poor church that is for the poor because they have much to teach us. But what is individual freedom? It is the freedom to be who you really are and to make mistakes and learn from them. Or as Nelson Mandela said, "to be free is not merely to cast off your chains but to live in a way that respects and enhances the freedom of others"

One of my first jobs in the UK was as Training Manager in a Foyer, which was a place where 60 young, homeless people lived in independent, one bedroom suites. It was my job to train them into becoming employable so that they would find a job and move into their own homes. Unfortunately the young Foyer Manager was an idealist and thought that these young people, who had evidently had a bad start in life should be given the freedom to live together without any rules. In fact they were asked to make their own rules. This caused havoc in this state of the art accommodation which was even better than a hotel. The plush carpets were soon destroyed with cigarette burns and the lift was constantly being broken by the residents - just for fun. Within six months we had nine pregnancies to deal with. Furniture was smashed and curtains torn to shreds - just for fun. This was the price the Foyer paid for the freedom given to the 16-25 year olds who had made it their home. On asking them why they had turned into vandals, their answer was simple. "Veronica, we came from homes where we didn't know who our father was. Our mother allowed us to do what we wanted because she really had no time for us and had no time to discipline us. So we want boundaries. We want tough love to show you care." What an eye opener this was for the young, naive manager. But it was almost impossible to undo the damage that had already been done.

So sometimes, freedom comes at a heavy price. The state of not being imprisoned or enslaved is a definition of FREEDOM but the young people in the Foyer were free yet enslaved by their addiction to love, the state of being loved, alcohol and finally even drugs. Yet for all purposes they were FREE.

The passing of the Freedom of Information Act in 2000, in UK, which gave anyone the right to access recorded information held by government and other public sector bodies was regarded as one of the landmark achievements of the last Labour government. But since then, former Prime minister Tony Blair described the law as one of his 'biggest regrets', since such transparency made it well-nigh impossible for ministers to have a 'safe space' to air their views. The media have made hay with the Freedom of Information Act and nothing recorded is a secret anymore. So freedom certainly comes at a price!

We can be enslaved by the desire for wealth, the desire for appreciation and recognition or even by our fear of sickness or death. This addiction reduces our freedom. Man is born free but he soon gets entrapped with worldly yearnings. Once they get a stranglehold on him, he finds it impossible to get out. That is why in John 8: 32 Jesus makes this cryptic remark to his listeners.... 'The TRUTH will set you free'. The Jews, proudly, claimed to be enslaved by no one. They forgot about the Egyptians, the Assyrians, the Babylonians, the Hellenists, and the Romans. But Jesus wasn't worried about empire and conquest and political freedom. He was concerned with freedom from sin. 'Love thy neighbour was Jesus' greatest commandment so if one doesn't follow Pope Francis' entreaty to work for the poor and downtrodden, we are allowing ourselves to be enslaved by the world and its temptations from a greed for power to a greed for pandering to the self. Once we remove the obstacles that keep us from loving our neighbour, we are truly free. But it is a huge price to pay. Not in terms of wealth but it terms of stamping out love of self. As ThichNhatHanh says in Anger:

*Wisdom for Cooling the Flames,* 'Freedom is the basic condition for you to touch life, to touch the blue sky, the trees,, the birds, the tea, and the other person'.

'What will people say?' was the never-ending chorus in my mind when I lived in India. What society thought of us was far more important than our own instincts and desire to do good. If I was seen working for the prostitute, the orphan and the beggar, I may not have been accepted by those in power and position. I may be shunned by my friends in high places if I am seen with the destitute and with the marginalised. These ugly thoughts cramped my style and I felt suffocated having to please the rich and famous. But I broke the bonds that tied me and moved to pastures new. Here in the UK, I am free to work for the refugee, the outcast, the prisoner and the pauper. This is what set me free. This was almost 25 years ago. I pray that things have changed in my homeland and reading The Mangalore gives me hope that attitudes have changed indeed.

I can't help quoting our Nobel Laureate, Rabindranath Tagore's poem...

Where the mind is without fear and the head is held high Where knowledge is free Where the world has not been broken up into fragments By narrow domestic walls Where words come out from the depth of truth Where tireless striving stretches its arms towards perfection Where the clear stream of reason has not lost its way Into the dreary desert sand of dead habit Where the mind is led forward by thee Into ever-widening thought and action

Into that heaven of freedom, my Father, let my country awake.

It would be fair to conclude with the words of Mahatma Gandhi who fought and died to give India her freedom. "Freedom is not worth having if it does not include the freedom to make mistakes." We will all make mistakes on the journey but as long as we pick ourselves up and get back on the path of truth, we will truly be free and the price we pay will never hurt us! Jai Hind!



# IRENE

Our mother was born in 1919. It was the end of the First World War. She was named Irene, derived from the Greek word peace, to celebrate the end of that conflict. Lyndon Johnson said "Peace is a journey of a thousand miles and it must be taken one step at a time." In her journey of nearly a hundred years, she brought peace and joy to everything she has touched.

Mummy was born and raised at the iconic 'Oorgaum House' in Bangalore. She developed an early love for reading at the Sacred Heart Convent and carried this passion with her for the rest of her life. We have fond memories of her curled up in her favourite sofa at Kelagur immersed in a book. After High School she got her Bachelor of Arts and Teaching in Mysore. Daddy was always proud of her "double degree" which was rare in those days.

Granny Rose was one of the original "outsourcers" in Bangalore. She outsourced parenting of the younger children to the older ones. The younger brothers were assigned to Irene. She taught them the value of deep religious faith, a love of learning and discipline. She was a highly disciplined person herself. She loved sweets but gave them up for Lent. Her mother used to hand out one sweet to each child after dinner. Irene hid hers. Her brothers spent most of Lent looking for her sweets. They had to find them before Easter Sunday because on that day she hid in the bathroom and ate them all.

In 1942, she married Eddie and moved to Kelagur. She was the perfect wife and gave Daddy constant and loving support in everything he did. They worked as a wonderful team together and it is hard to imagine him succeeding in life without her.

We were privileged to have had an extraordinary mother. Agatha Christie said "a mother's love for her child is like nothing else in the world. It knows no law, no pity, it dares all things and crushes down remorselessly all that stands in its path." We were lucky to have her clear the path for us. She was also the perfect grandmother. Her grandchildren have often travelled long distances just to spend a little time with her.

This motherly love and consideration extended to her virtual family. It included Peter and Lorna and their children after they moved to Kelagur, her many D'Souza and Mathias relatives and all the families that lived on the Estate.

1992 was a tragic year for Mummy as she lost her beloved Eddie after nearly 50 years of marriage. At first she was at a loss as there was so much he did for her. She had never written a cheque or reconciled a bank statement. But she was quickly back on her feet and started a new phase of her life as the Grand Lady of 1 Walton Road. She travelled the world as long as she could and then settled down to a quiet life in Bangalore. As she glided into her 90's she insisted on running her own home and was alert enough to complain about the cost of onions when Denis called her from California! Of course to do this she received unseen help from Sheela and Nicky in the background and support from her many loving relatives and friends.

On July 1, 2015 Irene passed away peacefully at 1, Walton Road. Throughout her life her faith in God was an important part of who she was. Her last words were "Jesus I trust in you".

Her ninety six years represented a life of consequence. It was a life focused on duty and responsibility. Her victory in life was that she did everything she could to be the best possible wife, mother and grand, great-grand and God mother, aunt, sibling and friend. ...never expecting anything in return. She lived up to the promise of her name Irene, because she brought peace to everything she touched. Her passing was the end of an era and a major milestone in the journey of the Kelagur Mathias and D'Souza families.

# CASK EYE-CAMP AT CHIKMAGALUR

If an impression is afloat that only the poor and marginalised patronise free eye camps, perish the thought. I tried to strike a conversation with a well-dressed couple with impressive stage presence thinking that they may be local volunteers at the camp. Y. C. Nanjegowda and his wife H M Kasturi are prominent citizens of Chikmagaluru. He retired as head-postmaster of the district after 40 years of service, mostly in rural areas. That is where he received help from Christian institutions, specially convents, in educating his three daughters. His first two daughters are MTech.. now married and settled in USA. The third daughter, who escorted her parents to the eye camp, is an advocate, now married and settled in Chikmagaluru.

Nanjegowda is waiting for his cataract to mature to operating stage and his wife has dry eyes (no tears!). A camp is an incentive to bring to the fore problems which we normally put on the backbencher – hoping that it will vanish. He was very effusive and kept stressing that the convents and Christian community helped him throughout his nomadic rural stints of duty.

An eye camp like the one organised by CASK is like mountain coming to Mohamed. Normally if one has dim eye sight, can't read or the distant object is a blur, one should be going to a doctor, clinic or hospital. But, poor, illiterate people are not confident to take such steps. The CASK-type eye camps are a stimulus for them to submit themselves to be tested and diagnosed by a team from reputed entities.

Coming back to the camp patients, 44-year-old Gohar finds it difficult to read the Koran which she does for one hour a day. She came after reading leaflets about the camp given at her masjid. Her husband is a helper in a lorry. They have three children, two daughters married and a son.

54-year-old Asif is a daily-wager waiting to be prescribed and provided free spectacles and get over his dim sight which makes it

difficult for him to use his mobile.

Abdul Gafoor, 70 years, is not new to spectacles, having his eye-sight tested at Manipal. A cooly, he has no TV in the house; but enhanced spectacle-aided eyesight will help him to read the Koran. He has been coming to the hospital bringing poor neibhours for treatment.

There are others like 66-year-old Gangamma and Jayamma,65 years, who had come from 25KM away after hearing about the camp from others. Jayamma is involved in cultivating vegetables and is not new to the hospital as she has visited it for other ailments.

All of the 249 must have had their interesting story to tell and above all hope for better eye-sight-138 of them were prescribed free spectacles and 26 refered for free surgery.

# **BANGALORE COMMUNITY COLLEGE** A DECADE OF SERVICE TO YOUTH

# Avis Deans, Bangalore

In May 2015, a milestone in the history of Bangalore Community College was celebrated - 10 years of dedicated service to the education of young disadvantaged youth in the city of Bangalore - a journey of learning, discovery, fulfilment and empowerment. Let us retrace our steps to the beginning of this memorable journey.

Origin and Mission: It began in June 2005, when Fr Sagayanathan, Parish Priest of Sacred Heart Church-Bangalore, had a dream-to reach out to many struggling young school dropouts and unemployed youth and provide them opportunities and skills required to enter the mainstream of society. "To include the excluded" is a need-based College Motto based on the mission of the Community College movement in India pioneered by Fr. Xavier Alphonse S.J, former Principal of Loyola College-Chennai and Director-Indian Centre for Research and Development of Community Education. Fr Alphonse was moved by the plight of the underserved youth and was sent to USA by the Jesuits to study the Community College system there. He studied it and adapted the system to suit our country. In a short span of 15 years, about 350 Colleges have been established throughout India. This is the need of the times, since we are a developing country with 60% of young people being underprivileged.

Fr.Sagayanathan started Bangalore Community College, under the Archdiocese Board of Education, on the Sacred Heart Church campus. To take up and steer this unique venture, he selected an exceptionally qualified and committed couple-Prof Albert Selvanayagam, a retired Zoology Professor of St Joseph's College-Bangalore, with >40 years' experience as a facilitator of learning, in a variety of areas and his wife Rosalind, an experienced Personal and Marriage Counsellor. Together they embarked on this worthy mission. The Selvanayagam couple, along with Fr Sagayanathan are the Founders of the Bangalore Community College, with Fr. Sagayanathan functioning as the Director.

The first batch of 100 students were admitted in June 2005, with one classroom, an office room and a room for Computer Lab in the main school building.

**Course Content** : The curriculum consists of a 10-month course comprising Functional English, Basic Computer skills with Tally, Life coping skills and Work skills for the posts like Office Assistant or jobs in Food/Beverage and Retail. These skills equip students to enter the workforce and also mould their personality and value system in order to face life's challenges. "**Fit for life and Fit for Job**" is the motto and driving force and 10-years down the line, it has fully achieved its purpose. Students are charged a nominal fee since no Government grants are received. Once the students complete the course, they are placed in jobs.

To date, around 650 students have passed out of its portals confident, self assured and ready to take on the working world. Thanks to the celebration of important festivals and events, their talents in music, dance, acting etc are fully exploited and resulted in enhancement of their leadership skills, team work and selfconfidence. A weekly program in Yoga has helped to instill discipline, serenity and resilience and in promoting physical and mental wellbeing. Sessions on Character development and interpersonal skills are taken by a variety of professionals, which has helped in the holistic development of the students.

Participation in Inter-Community College competitions in dance, music, public speaking and Mad-Ads has fostered a spirit of healthy competition, team work and co-operation.

**Partnerships**: Over the years, thanks to the professional acumen of Albert and Rosalind, Industrial Partnerships have been set up with Reliance Group, Presidency College of Hotel Management and Institute of Hotel Management that ensure on-the-job training, which helps in gainful post-graduation employment. Students have been placed in leading retail stores, Cafe Coffee day outlets, IT Companies and other enterprises that give them a start in life and enable them to support their family. Gradually with experience and hard work they climb the ladder of success and today many hold managerial positions. Several are even successful entrepreneurs. They continue their relationship with the college and return to share their success stories. Some seek guidance and counsel from Principal Rosalind, whose motherly care and concern is greatly valued. Our past students have become our ambassadors. They are eager to lend a helping hand to new students who pass out, thus living out the college ethos to serve and help uplift the other.

# WILMA PEREIRA PARTICIPATES IN THE WORLD SPECIAL OLYMPICS IN USA

Wilma Pereira an inmate and student of Manasa Rehabilitation and Training Centre for special children, Pamboor participated in the Special Olympics World Games held in Los Angeles-United States of America from July 25 to August 02, 2015.

Wilma has been an inmate of Manasa Centre for the last 3 years and was the only girl from Karnataka to be selected in the Handball team of India, participating in the Special Olympics. She has received training in Handball in Delhi, Uttar Pradesh and Chennai.

Handball is a physical and fast sport of intense physical contact, with shots being thrown at speeds approaching 100km per hour. It is played indoors on a 40m X 20m court with seven players (one goalkeeper + six court), which speeds up the game even more. The object is to score more goals than the opponents by throwing the ball into a D-shaped net. Handball athletes are known for their speed, agility, physical strength and stamina.

The Special Olympics at Los Angeles had 6,500 athletes and 2,000 coaches representing 165 countries, along with 30,000 volunteers and about 500,000 spectators. It was billed as the largest sports and humanitarian event of 2015.

Wilma is the daughter of Lawrence and Jacintha Pereira residing in Mangalore and the second child among their 5 children.
