INTRODUCTION

The Annual Report of the Association for the year 2023-2024 is presented. During the year, the Governing Council met 6 times to conduct the business of the Association, take appropriate decisions and organized various activities/programmes in pursuance of the objects of the Association.

The General Body Meeting of the Association was held at the Avila Hall, St Agnes College, on **10**th **September 2023**. 48 members attended and duly approved/adopted the Annual Report and the Audited Statement of Accounts for the year 2022-2023.

A thanksgiving mass was held prior to the AGM at St. Agnes Convent Chapel, concelebrated by Rev. Fr. Richard Coelho.

Ms. Nayana Fernandes-Programmes; 4. Ms. Patsy Lobo-Teacher Enrichment & Personality Development Programmes; 5. Editorial Team – Patsy Lobo (Editor), Joan Lobo, Dr Anand Pereira, Miss Trisha D'Souza & Hemacharya.

PATRON OF CASK - The President and office bearers of the Association periodically met the Patron of CASK-Rev Dr Peter Paul Saldanha, Bishop of Mangalore and briefed him about the activities of CASK.

1. ADMINISTRATION AND FINANCE: The Administration and Finances of the Association continue to be efficiently managed, with due adherence to the relevant provisions of the Income tax Act and the Registrar of Societies. The computerized membership records, accounts and the subscriber list of "Mangalore", including the Free Mailing List are constantly updated.

1.1. MEMBERSHIP

1.2. Enrolment of New Life Members – During the year 136 new members were enrolled and Life Membership fees collected was **Rs. 1,36,001**/-. This amount has been taken to Income and Expenditure Account.

2. Charitable Programmes

2.1. ANNUAL SCHOLARSHIPS 2023

CASK provides Scholarships under two categories namely (1) from Endowments; (2) Regular Annual Scholarships;

The scholarships are granted based on the low financial status of the families without any distinction of religion, caste, creed, marks or merit. Weightage is also given to problems faced by the families - Single parent, women abandoned by the husband, daily wage earner, domestic workers, suffering from major or chronic diseases, disabled etc.

- **2.1.1. Franklin Mathias Endowment** The core amount of this Fund is **Rs.6,67,732/-.** Interest accrued on investments of this Fund during the year was **Rs. 40,197/-**, which was utilized to grant Scholarships during 2023 for 2 students.
- **2.1.2. Annual Scholarships:** CASK has been granting Annual Scholarships for deserving students each year, mainly towards Books, Extra coaching and transport. **In 2023**, 46 beneficiaries were granted scholarships. Total amount of scholarships disbursed by CASK is Rs 4.55 lakhs; that is, Rs 3.55 lakhs of general scholarships and Rs 1 lakh to Manipur Students.

The Vicar General of Mangalore Diocese-Msgr Maxim Noronha distributed the Scholarships in the presence of the major donors, members and well wishers of CASK, on Saturday 8th July 2023 at the Bishop's House Kodialbail, Mangalore.

- **2.2.Status of CASK Centenary Celebration Fund:** The balance carried forward from the last fiscal year on account of this Fund was Rs. 32,89,415.42/-This amount, along with the Rs. 28,778/- earned as interest from investments, increased the balance to Rs. 33,18,193.42. This includes the value of the CASK office at Pio Mall-Bejai.
- **3.** "Mangalore" Magazine: "Mangalore" with Ms. Patsy Lobo as editor and Ms. Joan Lobo, Drs. Anand & Geetha Pereira, Ms. Trisha D'Souza & Mr. Hemacharya in the editorial team, has continued to maintain high quality and done a commendable job. With varied articles & News/Notes of interest, the magazine has continued to receive much appreciation from the readers.
- 4. During the year concerted efforts were made to collect arrears of subscriptions which yielded a total collection of over Rs 6, 71,000/-

6. OTHER PROGRAMMES

- 6.1. Due to unavoidable reasons, the Annual CASK Reunion was not held in 2023.
- **6.2. Placement of Flowers and Candles on Unattended Graves on All Soul's Day** 2nd November 2023 Members of the CASK Governing Council placed flowers and candles on 249 unattended graves in Milagres Parish and 190 unattended graves Angelore Parish on All Soul's Day 2nd November 2023.

- **6.3. International Women's Day Programme -** CASK celebrated International Women's Day on 9th March 2024 at 'Dev Kripa' Senior Citizen Home for Women. The 38 women in the home consisting of residents (18), Bethany Sisters (8) and Care-takers (12) were felicitated and honoured. Each received a gift of a set of towels.
- 7. CASK WEBSITE The CASK website: http://www.caskmangalore.org is operating satisfactorily. Apart from important information about CASK, the website has editorials and president's messages and selected articles of interest from the "Mangalore" magazine. We are grateful to Mr. Shubhakeerthi for uploading the necessary content on the website.

CASK continued its policy of collaboration with other organizations and associations based in Mangalore. During the reporting year, the organizations/institutions collaborated include the All-India Catholic Union (AICU), Christian Planters Guild, St Aloysius College, St Agnes College, Fr Muller Institutions, CODP, Rotary Club of Mangalore and Kanara Chamber of Commerce & Industry. CASK continued to be in contact with Kanara/Mangalorean Catholic Associations in different cities of India and abroad

FACT SHEET ON MONKEY-POX

The monkeypox virus was first discovered in Denmark in 1958, in monkeys kept for research. The first reported human case of mpox was a nine-month-old boy in the Democratic Republic of the Congo (DRC) in 1970.

On 15 August 2024, Sweden became the first country outside the African continent to confirm **monkeypox** (mpox clade Ib) in an individual with travel history to central Africa. The confirmation of the case came just one day after WHO's Director-General declared mpox **a public health emergency of international concern** (PHEIC) for the second time in 2 years, following an upsurge in new and concerning cases in the Democratic Republic of Congo and several neighbouring countries, including the emergence of a new strain – called clade Ib – which appears to be more severe than clade II, which has been circulating in the WHO European Region for some time.

People with mpox infection develop lesions that typically progress from papules, macules, vesicles, pustules, and then scabs. A person is contagious until after all the scabs on the skin have fallen off and a fresh layer of intact skin has formed underneath.





Following eradication of smallpox in 1980 and the end of smallpox vaccination worldwide, mpox steadily emerged in central, east and west Africa. A global outbreak occurred in 2022–2023 caused by a strain known as clade IIb. The natural reservoir of the virus is unknown – various small mammals such as squirrels and monkeys are susceptible.

KEY FACTS:

- Mpox (monkeypox) is an infectious viral illness caused by the monkeypox virus, a species of the genus Orthopoxvirus. Two different clades exist: clade I and clade II;
- Common symptoms of mpox are a painful skin rash or mucosal lesions which can last 2–4 weeks accompanied by fever, headache, muscle aches, back pain, low energy, and swollen lymph nodes; The rash begins as a flat sore which develops into a blister filled with liquid and may be itchy or painful. As the rash heals, the lesions dry up, crust over and fall off.
- Mpox can be transmitted to humans through physical contact with someone who is infectious, with contaminated materials, or with infected animals;
- Laboratory confirmation of mpox is done by testing skin lesion material by PCR;
- Mpox is treated with supportive care. Vaccines and therapeutics used for mpox in some circumstances.
- Mpox can be prevented by avoiding physical contact with someone who has mpox. Vaccination can help prevent infection for people at risk;
- Anyone can get mpox. It spreads from contact with infected persons, through touch, kissing, or sex or animals, when hunting, skinning, or cooking them or materials, such as contaminated sheets, clothes or needles
- It is advisable to stay at home until all scabs fall off and a new layer of skin forms
- Cover lesions and wear a well-fitting mask when around other people; avoid physical contact.
- Transmission-person-to-person transmission of mpox can occur through direct contact with infectious skin or other lesions such as in the mouth or on genitals; this includes contact which is faceto-face (talking or breathing), skin-to-skin (touching or

sexualcontact), kissing, respiratory droplets or short-range aerosols from prolonged close contact. The virus then enters the body through broken skin, mucosal surfaces (e g oral, pharyngeal, ocular, genital, anorectal), or via the respiratory tract.

- Mpox can spread to other members of the household and to sex partners. People with multiple sexual partners are at higher risk. Animal to human transmission of mpox occurs from infected animals to humans from bites or scratches, or during activities such as hunting, skinning, trapping, cooking, playing with carcasses, or eating animals.
- Some people may have one or a few skin lesions and others have hundreds or more. People with mpox are infectious and can pass the disease on to others until all sores have healed and a new layer of skin has formed
- Children, pregnant people and people with weak immune systems are at risk for complications from mpox. Typically for mpox, fever, muscle aches and sore throat appear first.
- In the context of the global outbreak of mpox which began in 2022 (caused mostly by Clade IIb virus), the illness begins differently in some people. In just over a half of cases, a rash may appear before or at the same time as other symptoms and does not always progress over the body. The first lesion can be in the groin, anus, or in or around the mouth. People with mpox can become very sick.
- For example, the skin can become infected with bacteria leading to abscesses or serious skin damage. Other complications include pneumonia, corneal infection with loss of vision; pain or difficulty swallowing, vomiting and diarrhoea causing severe dehydration or malnutrition; sepsis (infection of the blood with a widespread inflammatory response in the body), inflammation of the brain (encephalitis), heart (myocarditis), rectum (proctitis), genital organs (balanitis) or urinary passages (urethritis), or death.

- Detection of viral DNA by polymerase chain reaction (PCR) is the preferred laboratory test for mpox. The best diagnostic specimens are taken directly from the rash – skin, fluid or crusts – collected by vigorous swabbing.
- The goal of treating mpox is to take care of the rash, manage pain and prevent complications. Early and supportive care is important to help manage symptoms and avoid further problems.
- Getting an mpox vaccine can help prevent infection. The vaccine should be given within 4 days of contact with someone who has mpox (or within up to 14 days if there are no symptoms). It is recommended for people at high risk to get vaccinated to prevent infection with mpox, especially during an outbreak.
- Several antivirals, such as tecovirimat, originally developed to treat smallpox have been used to treat mpox and further studies are underway. Further information is available on mpox vaccination and case management. Self-care and prevention
- Most people with mpox will recover within 2–4 weeks. Take overthe-counter medications for pain like paracetamol (acetaminophen) or ibuprofen; Do not pop blisters or scratch sores, which can slow healing, spread the rash to other parts of the body, and cause sores to become infected; or shave areas with sores until scabs have healed and you have new skin underneath (this can spread the rash to other parts of the body).
- To prevent spread of mpox to others, persons with mpox should isolate at home, or in hospital if needed, for the duration of the infectious period (from onset of symptoms until lesions have healed and scabs fall off). Covering lesions and wearing a medical mask when in the presence of others may help prevent spread. Using condoms during sex will help reduce the risk getting mpox but will not prevent spread from skin-to-skin or mouth-to-skin contact.

MESSAGE BY POPE FRANCIS – 12 AUGUST 2024

Pope Francis told a group of priests and religious women recently "God will not judge people by how many university degrees they earned, but by how well they cared for the poor",

"The Lord won't ask us, 'What did you study?' 'How many degrees do you have?' 'How many works did you accomplish?' No, no. The Lord will say, 'Come with me because I was hungry and you gave me to eat; I was thirsty and you gave me to drink; I was persecuted and you protected me," the Pope said.

"That is the theme of the final exam on which we will be judged," the pope said on Aug. 12 as he met members of the general chapters of the Dominican Missionary Sisters of St. Sixtus, the Society of the Sacred Heart of Jesus, the Sisters of the Presentation of Mary and the Vocationist Fathers

Pope Francis joked that it was "efficient" of the Vatican to group all the general chapter members together in one audience since it is chapter "season" in Rome.

All four religious orders, he said, were founded to support and educate young people from poor families who would not otherwise receive the education they needed and the guidance necessary to discover their vocations.

The founders of the four orders "saw in them a sign from God for their mission," the pope said. "In the same way, it will also be good for you, especially in these days of community discernment, to keep constantly before your eyes the face of the poor."

"Jesus speaks to us in our neediest brothers and sisters," Pope Francis said, "and in every gift given to them there is a reflection of God's love."

And while the art of spiritual discernment is a specialty of the vocationist fathers, the pope told the religious that learning to make decisions by listening to God, to others and to one's own heart is essential for all Christians.

Discernment, he said, involves "prayer, meditation, patient waiting, and then courage and sacrifice" to put into practice that which God, "without ever imposing his will on us, suggests to our hearts."

Having choices is a sign of the freedom God gives to each person, the pope said.

"Our world is in such need of rediscovering the taste and beauty of making a decision, especially regarding definitive choices, which cause a decisive turning point in life, such as the vocational one," he said. Young people need spiritual fathers and mothers to help them understand that "to be free is not to remain eternally at a crossroads, making little 'escapes' to the right and left, without ever really taking a road."

"Being free means betting - betting - on a path, with intelligence and prudence, certainly, but also with boldness and a spirit of renunciation, in order to grow and progress in the dynamic of giving and to be happy and loving according to God's plan," the pope told them.

REMEMBERING BEATRIX (TRIXIE) NORONHA

Beatrix Noronha our beloved Mother was also our mentor, teacher, 'confessor', advocate and moral compass. We - Ivan, Doris, Peter, Rita, Joseph and Stephen are the fortunate and ever grateful children of Diony and Trixie Noronha.

Our parents were decent, gracious and loving people. Family came first, community and neighbors were treated with love and respect—doors were open to just anybody, connections were made and nurtured. Mom and Dad's hospitality and generosity knew no bounds. Our home "Devadan" in Bangalore was the popular venue for a great many family gatherings over decades. Dad died on April 6, 1977, followed by Mom on August 19, 1996. Years after their deaths, they remain respected and admired by the Bangalore and Mangalore Catholic communities. Sweet memories linger.

This tribute is written to honor our darling Mother, on what would have been her Centenary birthday - August 16,2024

Beatrix Mary Matilda was the eldest child of Charles and Doris (Peris) Noronha. Charles Noronha belonged to one of Bangalore's prominent Mangalorean families. Charles was an eminent Catholic in Government service, rapidly rising in the State official ranks. Doris Peris was a highly accomplished young lady and the eldest daughter (of seven) of another then very few Mangalorean families from Bangalore. Charles and Doris were wed at St Patrick's Church, Bangalore, in November 1922. This idyllic marriage lasted for just 10 years and bore four lovely children, Beatrix (Trixie), Elsie, Anthony (Tony) and Elizabeth (Betty). Doris died on Apr 11, 1933 at age of just 32, leaving Charles and four young children bewildered and bereft. At not yet 9 years, Trixie was the eldest, Betty at 3 was the youngest. The children were entrusted to the care of the expanded family especially their Aunt Rose and Charlie's revered stepmother Pulcheria.

Three years after Doris's death, Charles married Louisa (Lizzie) Colaco. By this marriage, he had another four children – Loysie (who died in infancy), Cecil, Flavia, and Vivian. Professionally Charles grew from strength to strength. His life too was cut short. After a long and painful illness, Charles passed away on the morning of 14th March 1950. From the time of her Mother's death to the time of her marriage,

Mom had the responsibility of looking out for her three younger siblings. Despite those personal issues, she was a star student, with multiple musical and other creative talents. Her schooling was at the prestigious Sacred Heart High School at Good Shepherd Convent, Bangalore. The extended family regularly organized the trips to school for the siblings, in a horse driven carriage. In the year when her father was posted to Chikmagalur, 140 miles away, Charles kept Trixie, Elsie and Betty as boarders in Good Shepherd Convent and Tony at St Joseph's EHS so as not to disrupt their schooling. While on holidays in

Chikmagalur, Trixie was introduced to horse riding and other outdoor activities.

Trixie made her First Communion at St. Patrick's Church in Bangalore in 1931. A photo of that memorable occasion is preserved in the Centenary Bulletin of St Patrick's.

On completion of school, she enrolled at the venerable St. Joseph's College for two years of Inter. She was looking forward to earning a Bachelor of Arts in college, but that changed when the proposal of marriage came at age 19.

By this time she had become a gifted pianist, with a beautiful voice to match. We have heard stories that Trixie was a very popular young lady in social circles. Many of her friends from those early years remained very close and special throughout her life.

Beatrix was married to the dashing, 28 year Dionysius Noronha on September 15, 1943, in a rarely permitted evening service at St Patrick's Church. The following excerpt is from a report of the wedding, featured in the community magazine 'Mangalore' (issue of October 1943): "One of the grandest and most largely attended weddings in our community took place in Bangalore on the 15th of September. The pretty bride looked most charming as she was led to the altar by her father, while the organ poured forth soul-stirring music. A grand reception was held in the Glass House at Lalbagh amidst very pleasant and picturesque surroundings. His Grace the Archbishop of Madras, who came all the way from Madras to attend the wedding, proposed the toast of the newly-married couple in eloquent terms. He remarked that the happy couple represented the union between two reputed, talented, and greatly respected Catholic families. His Grace said that he cherished a high regard and admiration for the bridegroom whom he had known for well-nigh 9 years, and he could safely foretell that one day he would grace the Madras High Court".

In the early years of his judicial career, Dad was posted to different cities in South India, including Mangalore, Kasargod and Coimbatore. Wherever he went, so did Mom. There is little, we siblings remember of our early childhood in those different places. Permanence for a period of about 10 years came in our move to





Mangalore. Dad was posted to Mangalore in the early years of the marriage, in special consideration of his parents' old age and his father's recent stroke. Sylvester a respected businessman and land owner, had been a very active person, but with a complete change in lifestyle after this acute medical event. A few years after the family moved to Mangalore, Dad's mother Juliana also suffered an illness that resulted in her being bedridden the rest of her life.

Our mother, then with four children, soon to be five, had to take on the formidable additional responsibility of providing care to her chronically ill in-laws. She also had to oversee the functions of a large and busy household - the ancestral Home, Julie Bagh. In addition there was involvement with important matters of the heart and mind relating to the second family which Dad inherited by virtue of being the late Charles Noronha's eldest son-in-law. Mom and Dad were now the 'connecting link' between the three young 'step-siblings'. All this would have been enormous challenges for Mom, and it must have taken acceptance, patience and discipline to make a seamless transition.

Charles Noronha died in 1950 and our father stepped into his shoes with the able and loving assistance of Mom. In later years, Flavia and Vivian in particular would recall that Trixie was like a mother to them.

Our mother was not cognizant of many of the local cultural norms in Mangalore, but came to quickly understand and embrace these. She also undertook with grace the role of an Officer's wife, at formal and various other events. She found time to play tennis

at the local Ladies Club, and became involved with other activities of that still flourishing organization. Mom's benevolent nature, charming smile, and ever evident generosity, earned her affection and admiration of the Mangalorean community. Because of her guidance, counsel and rapport, our Mangalore childhood and schooling was most enjoyable.

After that decade, there began a nomadic period of four years when Dad was stationed to other cities in Karnataka State, sometimes transferred with little warning. To his credit every step was a higher level, leading ultimately to an honored career in the judicial system. Time and time again Mom had to bear the burden of managing the many logistics of changing houses, schools, churches etc. There were also major differences in the local dialect and social mores, in each city. In the final phase of our lives, we moved to Bangalore in blissful

contentment. Professionally, our father quickly rose to be Head of the Karnataka Vigilance Commission. The crowning glory of his career was the appointment as a Justice of the Karnataka High Court - the first ever Mangalorean Catholic to be so assigned anywhere in the country. During this busy tenure on the Court, our mother was a willing and gracious partner when Dad was the chief guest and/or speaker at ceremonial events. On many an occasion, she was the chief guest.

'Devadan' so named by Dad was the hallowed Home, where we spent our formative years. It was a also a second home to a great many. Besides us six siblings, there was constant accommodation of cousins and others who came to Bangalore for studies or jobs. After our father died in 1977, most capably and with determination, Mom took on the role as the head of Devadan. She directed and supported each of her children, as we sorted out our interests and passions. When problems arose, Mom would make a wise summation of the same, intervene and come up with sound solutions. She spent a lot of her time in tutoring us in studies as well as made sure that we would diligently practice our music. She was instrumental in guiding us to choose the careers we have, and for influencing the lives we lead. Her positive attitude and words of encouragement will remain with us forever. A charming lady, smiles came naturally to her, a great sense of humor was evident and we revelled in that unforgettable cascade of girlish laughter. We loved making our Mom laugh.





Devadan was the popular venue for many celebratory occasions like birthdays, wedding events and family reunions. Our father and mother were also actively involved in a variety of acts of piety and philanthropy. Among mom's activities were commitment and volunteer work for all the different schools we attended. Mom was busily engaged in a number of charitable groups such as the Catholic Women's League, Good Shepherd Past Students and Parents Association, and Ladies of Charity. She invested enormous time to St. Patricks Church, where she was in the choir and played the iconic Pipe Organ, for over fifteen years. She was the Editor of the Children's Corner section of the monthly Parish newsletter the 'Patrician', under the pseudonym "Aunt Patricia". But her most passionate purpose was for the children at St. Patrick's Orphanage (now St. Patricks Boys Home). These children were loved and pampered, as also tutored in singing and music. There was special attention given to the developmentally challenged. As part of Ladies of Charity activities, she would participate in feeding of the poor, often going to the slums in the hot afternoon sun. Other endeavors for the St. Patrick's boys included knitting sweaters for them. Even during later years of her home confinement, she continued to be a patron for the orphanage. Our mother had over several decades given so much of her time, energy, and tangible contributions to the welfare of these orphaned children. Groups of these kids would in turn make visits to Devadan. in the years Mom was physically limited. Their happy chatter and voices would evoke that beautiful smile.

The three eldest sons had left India, before our mother was stricken by an illness that would affect her physical abilities in profound ways. It must have really hurt her, to see one child after the other leave the nest in Bangalore, to be so far from most of her grandchildren, miss family milestones and celebrations aplenty. In years of good health she did manage to make a couple of trips to the West, including one memorable trip to Rome where she received an audience with Pope Paul V1. We brothers, Ivan, Peter and Josie would get back to Bangalore for a few weeks as often as we could, to bask in the warmth of her overwhelming generosity and boundless love. Our sister Doris lived in Bombay but her son Niren spent the bulk of his schooling years in Bangalore. Five of us siblings were most fortunate that we had a champion in our beloved sister Rita, to care for our mother through the decades of Mom's disabling affliction. There was too a small team of loyal and compassionate caregivers, who our mother genuinely loved and trusted. They assisted her in fulfilling mundane as well as favorite activities and in maintaining social connections. They were a respected part of the family.

Mom kept in constant touch with her sons abroad, with regular mailed letters. Her handwriting was sublime, her prose perfect. Those letters were scripted as frequently as once a week. She wrote often to many others as well. Among them, the parents of one of her several Godchildren, 'Diotrix', uniquely named because of one family's love of Mom and Dad. This time consuming practice of communication was pursued, even after the first stroke robbed her of the use of her writing hand. She learned how to write with her left hand and when successive strokes affected that side of her body, she struggled anew to keep the letters coming. As her strength and dexterity withered from those cruel blows of fate, the lines became fewer, the words larger and increasingly misshapen, but the letters were still written remarkably often. A true labor of love.

The weddings of the four sons over a span of 12 years took place in India, all but one in Bangalore. When in good health but even after several strokes, our mother was actively involved in the organization of these events. If there ever was evidence needed, that even when profoundly physically disabled, she could manage with finesse a large Indian Catholic wedding, it was that of Steve and Sandy in 1988. This would be the last time that the DIOTRIX clan - all her children, their spouses and grandchildren were gathered in one place - Devadan. Our beloved matriarch was in her element. Love radiated from her face. Joyful pride reigned.

The last years of her life left our mother disabled and bedridden, presenting a challenge that most could never have coped with. Yet she did so with total stoicism, faith and hope. If there was anything good about her suffering - it was that she endured it to be an example, a teacher. Mom's will to do good, never ceased. Her children and



her grandchildren (on short visits to Devadan) were embraced by her loving affection. These toddlers lapped up the attention and affection. Mom taught and influenced all of us by the life she lived, in health as well as in illness.

At the time of her death the outpouring of love and sorrow from the community was immense. We had never seen so many people at a

funeral in all our years in Bangalore. The image that will forever linger in our minds, is the guard of honor that the boys of St. Patrick's gave her. As the cortege carrying her body came into the expansive grounds of St. Patrick's Church, hundreds of children stood side by side holding candles, saluting her and singing as a unique chorus. This was a glorious sight to behold. It wasn't just the six of us who had lost a mother. It was too, all those young boys at her funeral, and many many others. Of hundreds of messages received on her death, one summed it up perfectly. "Trixie Noronha is no more. A saint has gone to receive her eternal reward. Trixie was an example to whoever saw her. Her unwavering faith in God, strengthened our own faith in Him. A beautiful life is no more. But she has left the fragrance of her life to imitate".

Our parents were truly extraordinary people. Our mother's whole life was one of selfless devotion. Besides doing everything possible to keep us kids happy and healthy, Mom went out of her way to make others also feel like part of the family. Scores of people even today, reminisce about the genuine warmth and hospitality of our mother, and the haven that was Devadan.

It is possible that they represent more for me from a childhood full of memories and an adolescence full of even more. Swings will forever be able to take me back in time and every sweet memory I cherish.. Remember that feeling when you get at the apex of the swing and seem to be floating? The risk involved at that exact moment, seemingly suspended in mid air, and the drop after that is so cool. There is the exhilarating feeling at that pinnacle of height that gives us a mental and physical adrenaline rush. It makes the whole swinging experience awesome. We were delighted as we learnt the feeling of accomplishment and gratification while we were swinging. It was a great fun workout.

Fiction of Law & Capital Gains Taxation

Those who wish to explore the concept of Fiction of Law will find interesting examples of the same in the labyrinthine maze called Income Tax Act 1961. A legal fiction in simple words is defining something to be true for the sake of convenience. Of course, "convenience" is something that the government of the day decides through deeming provisions in the statutes passed by the legislature. When it comes to construction of tax statutes it is important to bear in mind that the concept of "natural justice" is rarely considered, as courts have consistently held that "tax and equity are strangers" which implies that fiction of law is taken to its logical conclusion even when such conclusions appear to be illogical!

Capital gains is defined differently for different kind of assets and their taxation varies depending on the type of asset and its holding period. Fortunately, Budget 2024-25 has simplified the definitions and taxation provisions to some extent. Following table summarizes the changes.

The revised LTCG tax now provides a more favourable environment for overseas investments, at a time when Indian markets are overvalued. Investors, HNIs in particular, through the GIFT city in Gujarat, could directly invest up to \$250000 in a financial year under the RBI's Liberalized Remittance scheme in overseas equities/funds. International equities/funds now enjoy parity with Indian equities, albeit with a 24 month holding period for LTCG classification, down from 36 months earlier. Another opportunity that opens up for HNIs is in the space of unlisted shares, since the tax harmonization proposed in the budget aligns the taxation of gains from unlisted shares with that of listed shares except for the waiting period, to be eligible for LTCG taxation.

But in a country with aspirations of being Vikshith Bharath before long, the need to accelerate investments backed by risk capital cannot

be overemphasized. But the last few budgets of FM Nirmala Sitharaman seem to be increasingly diluting the significance of this source of high powered savings garnered though equity capital when it comes to tax treatment. While increasing short term capital gains tax is understandable, increasing the same on long term capital gains on equities is something that cannot be appreciated in an economy that is hungry for high powered risk capital. A better option to consider would have been to increase the holding period to, say, 2 years and abolish tax on gains made thereafter. Given the speculative fervor fuelling the markets at present, this change might turn out to be revenue neutral, if not positive.

It is also encouraging to see the Finance Minister heed the concerns raised by a large number of investors on removal of indexation benefit on investments in house property/land which would affect investments made prior to the budget. She moved an amendment to the proposed LTCG taxation in respect of realty sector. In the case of transfer of a long term capital asset being land or building or both, by an individual or HUF which is acquired before July 23, 2024, the taxpayer can compute tax under the new tax rate at 12.5% without indexation and the old scheme at 20% with indexation and pay tax which is lower of the two. It has to be appreciated that the Finance Minister has honoured the promise to ensure that changes in taxation rules are not brought about with retrospective effect.

Treatment of capital gains in the case of buyback of shares, however, leaves some questions unanswered. Earlier buyback proceeds were tax free in the hands of the shareholder as the tax was paid by the company which meant that the tax burden was borne by the continuing shareholders and not the seller. This provision is now replaced under which the entire sale proceeds of shares sold in the buyback offer is treated as dividend in the hands of the shareholder and taxed at slab rate. The cost of acquisition of the shares sold is treated as capital loss which can be set off against future capital gains. This is likely to result in companies almost entirely resorting to buyback through open market purchases instead of through tender offer. Shareholders who sell shares

during the period when the company is buying back its shares in the open market will pay only 12.5% LTCG tax and not on the sale proceeds at the applicable slab rate as proposed under the new provision when shares are sold under the buyback offer. Well, it is possible to resort to a fiction of law through a deeming provision which could state that proceeds of any sale of shares of the company in the period during which the company is buying back its shares from the open market will be treated as dividends! It seems that such treatment may not only be regarded as discriminatory but turn out to be disruptive and hence may not be feasible. But bureaucrats are known to have resorted such to quixotic proposals in the past! Another complication can arise when a company takeover occurs, where an offer for usually 26% of the total shareholding has to be made to the public shareholders. How will the sale proceeds be taxed in such cases? This question remains to be resolved

It is worthwhile to note that the existing provisions that enable an investor investing in residential property and specific bonds, to minimize capital gains tax outgo are retained.

Under Section 54, the seller of residential house property is required to invest the sale proceeds in another residential house property in India to be constructed within three years or to be purchased within two years from the date of sale or to have been purchased within one year before the date of the sale. In case your capital gain does not exceed Rs 2 crores, you can invest in not one but two house properties, although this option is available only once in a lifetime. The quantum of exemption under this section shall be lower of:

- a) Capital Gains,
- b) Cost of new asset (limited to Rs 10 crores)

This exemption comes with a three year lock-in period on the new asset.

Under Section 54EC, taxpayer gets exemption if the capital gains from sale of land, building or both are invested in specified bonds issued

by REC, PFC etc. Maximum investment in these bonds is capped at Rs 50 lacs in a financial year. The quantum of exemption under this section shall be the lower of capital gains or cost of the bonds purchased. These bonds at present carry a coupon rate of 5.25% and have a lock-in period of 5 years. It has to be noted that even the act of using these bonds as collateral for loans will be considered a breach of lock-in period.

Section 54F deals with exemption from long term capital gains on sale of all kinds of capital assets (including shares, mutual funds) except residential house properties. To claim the exemption under the section, taxpayer has to invest the sale proceeds in one residential house property in India to be constructed within three years or to be purchased within two years from the date of sale or to have been purchased within one year before the date of sale. The quantum of exemption is calculated as A*(B/C), where A is the capital gains on sale of the original asset, B is the cost of the new asset and C the proceeds from the sale of the original asset. B, that is cost of the new asset, is however limited to 10 crores. Further, the following conditions have to be satisfied to be eligible for the above exemption.

- The assessee should not have owned more than one residential house apart from the new asset, on the date of sale of the original asset.
- 2. The assessee should not have purchased another house property, apart from the new asset within two years from the date of sale of the original asset and should not have constructed another house apart from the new asset, within three years from the date of sale of the original asset.
- 3. A lock-in period of three years applies to new asset.

Claiming exemption under one of the above sections does not preclude an eligible taxpayer from claiming exemption under another section as per expert opinion.


It was a wonderful opportunity for 200 plus entrepreneurship aspirants and budding entrepreneurs in a unique platform.
